School Sport Victoria, as part of the Department of Education and Training, delivers an extensive school sport program to primary and secondary students across Victoria.

School Sport Victoria is seeking student feedback to inform the future of school sport in Victoria.

Students are encouraged to nominate for the SSV Student Leaders Group for 2023.

As part of the nomination, consent is required from both the students' parent/carer and school Principal to participate.

This consent form is to be signed and attached as part of the student's application. Further details on applying for the SSV Student Leaders Group webpage on the SSV website.

As part of the SSV Student Leaders Group, student feedback will be sought through:

- Online group discussions, facilitated by two designated facilitators appointed by School Sport Victoria. A qualified
 teacher appointed by School Sport Victoria will also be present in the group discussions. These group discussions will be
 held during school time and it is expected that the student's school provides supervision during their participation.
- A face-to-face group session, to be held in metropolitan Melbourne. Further details will be provided as well as a consent form specific to this excursion.

A School Sport Victoria staff member may be present in the group sessions (online and face to face).

IMPORTANT INFORMATION FOR PARENTS/CARERS AND SCHOOLS

Department's collection, use and disclosure of personal information

The Department intends to use, disclose and store student feedback as part of the SSV Student Leader Group discussions (online and face to face) to inform future opportunities for student engagement in sport and physical activity.

Where appropriate, school staff or service providers may access information collected in these discussions for permitted purposes.

What information will be used?

Students will be encouraged to express their personal feedback and experience as part of the SSV Student Leader Group discussions.

Any reporting on student feedback will be provided to School Sport Victoria at an aggregate level where individual contribution is de-identified.

The following information about the student will be noted and used to inform any small discussion groupings, however it will not be used to identify a student in any reporting on student feedback: student's name, gender, age, whether the student is of Aboriginal or Torres Strait Islander descent, languages spoken at home other than English, participation in sport and whether the student has a disability.







Will sessions be recorded and/or images of students taken?

The School Sport Victoria Student Leaders Group discussions will not be recorded, to allow students the freedom to share their views, opinions and feedback within members of the group.

However, School Sport Victoria would like to share the outcomes of the group's work and therefore is seeking permission to capture images or videos of students, to share the experiences of students who have participated in the group discussions.

How do we protect personal and other information?

Victorian privacy laws require School Sport Victoria, as part of the Department, to handle personal and health information in accordance with the <u>Information Privacy Principles</u>. The Department takes steps to ensure data is securely handled, such as: privacy assessments, contractual arrangements and monitoring.
